The human resource management in the transition analysis were investigated by the scientists of Lithuanian Sports University and other Lithuanian universities. V. Indriuniene *et al.* investigates the efficiency of solution focused brief coaching in enhancing leadership and workers' motivation. V.B. Fominiene and L. Jeseviciute-Ufartiene deal with the actual issues on the interface between the employee attitude to teamwork and communication skills: example of sports clubs. D. Perkumienė *et al.* researches the peculiarities of working time organization regulation in the sports sector.

The issues of culture and leisure industry were discussed by the scientists of Lithuanian Sports University and other Lithuanian universities. D. Reklaitiene *et al.* presents the accessibility for people with disabilities – new challenge and possibilities for fitness and recreation services development. S. Sukys researches the exercise services availability association with young adults' leisure time physical activity and personal health. R. Mikalauskas and J. Kaspariene analyse the holistic approach towards leisure industry.

The international challenges for economics and management development were investigated by the scientists from Slovakia and Lithuania. A. Kljucnikov deals with actual issues to uncover SMEs finance through the impact of the specific factors, on the basis of evidence from Slovakia. M. Draskovic *et al.* presents a quasi-neoliberalism as quasi institutional monisms and causes of the crisis in South-Eastern Europe. T. Saulius *et al.* researches the culture as a scientific concept and implications for international business communication. B. Svagzdiene and J. Kuklyte present in the article the analysis of factors which have impact for summary innovation index in Germany, Estonia and Lithuania.
